PROJECT DESCRIPTION:

The Port of Edmonds is proposing the following improvements to the Port of Edmonds Marina:

- reconstruct and repair a segment of seawall;
- reconstruct and renovate the North Portwalk;
- construct two new pedestrian plazas that include new restrooms; and
- renovate the adjacent parking lot.

PROJECT LOCATION: Parcel 27032300401400, located at 336 Admiral Way in Edmonds, Washington.

Construction will take place on the northern portion of the property.

STATE ENVIRONMENTAL

POLICY ACT: The Port of Edmonds, acting as lead agency, issued a Determination of

Nonsignificance (DNS) for the proposal on October 25, 2021 (SEPA # 202105751). The proposal may require conditions and mitigation measures under the applicable codes outside of the SEPA review process. A copy of the threshold determination may be

obtained upon request.

REVIEW PROCESS: The design review of the project is a Type III-B decisions while the shoreline permit is a

Type III-A decision. The two applications are being combined pursuant to ECDC 20.01.002. When applications are combined, the ADB's review of the design review aspects of the proposal will result in a recommendation to the Hearing Examiner who will make the decision on the design review and shoreline permit following a public hearing. The Hearing Examiner will hold a public hearing to take public comment on

the proposal as a whole.
