1) The Principal and Surety agree that in the event that any of the improvements installed by the Principal or Surety pursuant to the above referenced plans, conditions and file fail to remain the free from defects in materials, workmanship or installation or in the case of landscaping, fail to survive for a period of year(s) from the date of acceptance of the installation by the City the Surety shall, upon demand of the City and the failure to cure the defect within a reasonable ime as determined and specified by the City, remit to the City within ten (10) days of receipt of demand for remittance, the amount of this bond or such lesser amount as may be specified in the demand.
2) If the Principal fails to cure any defect within the time period requested by the City, it employees and agents are hereby authorized to enter onto said property and perform said work. This provision shall not be construed as creating an obligation on the part of the City or its representatives.
3) In the event any lawsuit is instituted by the City of Edmonds, the Principal or th

Surety to enforce the terms of this bond or to determine the rights of any party hereunder, the prevailing party in such litigation shall be entitled to recover from the losing party its

costs, including reasonable attorneys' fees, incurred as a result of such lawsuit.
